

**DOG LICENSE:**

Individuals owning a dog within the City of Harrisonburg is required to obtain a dog license for each dog he/she owns pursuant section 15 – 2 - 8. It shall be the responsibility of the owner to present a valid Rabies Certificate signed by a licensed veterinarian for each dog. Rabies vaccination is required pursuant section 15 – 2 – 6 of the Harrisonburg City Code. These licenses are available at:
