At a Reorganization Meeting held in the Council Chamber this morning at 10:00 A.M. there were present:- Councilmen Erickson, Cline, Denton, Dingledine and Green; City Manager Milam, Clerk Loker and City Auditor Shifflet. Absent:- City Attorney Lapsley and Chief of Police Ritchie. Capt. Presgrave sitting in for the Chief.

Manager Milam presented for recordation, Oaths of Office as signed by Mr. E.Warren Denton, Jr. and Dr. Walter F.Green, III, for 4 year terms ending August 31, 1978.

The following action was taken re a,b,c,d, and e under Re-organization.

For Mayor:

On metion of Councilman Green, seconded by Councilman Dingledine, and a unanimous vote, Mr. Roy H.Erickson was reappointed as Mayor of the City of Harrisonburg for a 2 year term, expiring Aug. 31,1976. Mr. Erickson abstaining from the vote.

For Vice-Mayor:

On motion of Councilman Dingledine, seconded by Councilman Green, and a unanimous vote, Mr. E.Warren Denton, Jr., was reappointed as Vice-Mayor for the City of Harrisonburg for a 2 year term to expire on August 31, 1976. Mr. Denton abstaining from the vote.

For City Manager:

On motion of Councilman Green, seconded by Vice-Mayor Denton, and a unanimous vote of Council, Mr. Marvin B.Milam was reappointed to serve at the pleasure of Council, as City Manager for the City of Harrisonburg.

For City Clerk:

On motion of Councilman Cline, seconded by Vice-Mayor Denton, and a unanimous vote of Council, Mrs. N.Arlene Loker was reappointed to serve as City Clerk, at the pleasure of Council.

For City Auditor:

On motion of Councilman Green, seconded by Vice-Mayor Denton, and a unanimous vote of Council, Mr. R.William Shifflet was reappointed to serve as City Auditor, at the pleasure of Council.

Mayor Erickson expressed appreciation for the confidence of his fellow councilmen in his reappointment, touched on healthy changes which have taken place in the community such as the Skidmore Dam Pro-

ject, Cantrell Ave., Hose Co. No. 4 building, etc, and stated a hope that progress would continue as well

as it has in the past.

Other than reminders by the City Manager of Council's visit to the Mobile Home Site on Country Club Rd. this morning, and a meeting tomorrow at 10:30 with the Soil Conservation Service re contracts for the Skidmore Dam project, there was no further business and the meeting adjourned at 10:40 A.M.
