Search Warrant Leads to Arrest of Rockingham County Resident

HARRISONBURG, Va. – On February 1st, 2024, officers from numerous local law enforcement agencies executed a search warrant at a residence in the 11000-block of Wampler Road in Rockingham County. The search warrant obtained by a Detective with the Harrisonburg Police Department (HPD) was in relation to several crimes that occurred in Harrisonburg and surrounding jurisdictions.

There have been several independent investigations related to numerous residential and commercial break-ins in Harrisonburg and Rockingham County since September of 2023. Law enforcement officers from the Harrisonburg Police Department, Rockingham County Sheriff's Office, Virginia State Police, and Virginia Department of Wildlife Resources all collaborated on this multi-jurisdictional investigation.

As a result of the search warrant, stolen items were recovered and immediately relatable to six total active cases and several additional cases that are still under investigation. The total value of items recovered so far is estimated to be around \$45,000.

The suspect, Vladimir Petrovich Mazur, 35 years, of Wampler Road was immediately taken into custody and transported to the Rockingham County Jail. Current charges on Mazur include:

18.2-108 – Receive stolen goods (4 counts) – Felony.

18.2-308.2 – Felon in possession of a firearm – Felony.

18.2-308.2 – Felon in possession of ammunition – Felony.

18.2-250 – Drugs: Possession of Schedule II (2 counts) – Felony

18.2-308.4 – Possess gun with Schedule II – Felony

18.2-108.1 – Conceal firearm – Felony.

18.2-91 – Enter Structure to Commit assault and battery – Felony.

18.2-95 – Grand Larceny – Felony
