The Bicycle & Pedestrian Subcommittee met on Monday January 28, 2013 at 6:00pm in the Community Development classroom, 409 South Main Street, Harrisonburg. Meetings are always open to the public and citizens are encouraged to attend.

Members present included: Thomas Jenkins, Len Van Wyk, Charlie Chenault, Carl Droms

Welcome

Public comments, limited to 5 minutes each, for topics not on the agenda.

Mr. Neupauer noted that there are new street name signs at are very large and easy to read. However, there are still signs in the City such as at Mt. Clinton Pike and Kratzer Ave, and Route 42 and 2nd Street where the signs are still very small. He was concerned about safety and asked what the standard was and when all the signs would be updated. Ms. Dang stated that the larger, easy to read signs are the newest standards and although she knew that all city signs were being replaced with the new standard, she did not know the schedule for changing them. She will find out and get back to him. Note: Following the meeting Ms. Dang inquired with city staff. As old signs require replacement due to damage or age, they will be replaced with the new signage standard.

Officer Drugo brought up Ramblewood Park and the future recreational facilities, specifically mountain biking, disc golf, and the Bluestone Trail, planned there in relation to the active pistol/riffle shooting

range that the Police are currently using. There was acknowledgement from the subcommittee that Parks & Recreation and Police Departments needed to coordinate more on these projects.

Business

1. Update: New Bicycle & Pedestrian Subcommittee Member

Mr. Jenkins recapped that the Subcommittee opened the application process for a new member a few months ago. There were 7 applicants. The Subcommittee has selected their recommendation to the Transportation Safety Commission and the Commission will appoint a new member at their February 13 meeting.

The Subcommittee has established terms. Therefore, there will be new positions available every year. Applications for terms beginning January 2014 will be available in late-September 2013. The next terms to end will be the ones currently being filled by Mr. Jenkins and Mr. Chenault. Current Subcommittee members may reapply for the next term.

2. 2013 Meeting Schedule (Attachment A)

Subcommittee members approved the schedule in Attachment A.

3. Update: Pedestrians Crossing South Main Street

Ms. Dang described the ongoing issue with pedestrians, primarily students at James Madison University, crossing mid-block across South Main Street instead of using the tunnel/viaduct or crosswalks at signalized intersections. On January 9, the Transportation Safety & Advisory Commission, sent a letter to James Madison University Public Safety asking Public Safety to consider placing 3-4 officers in the area of South Main Street at random times to interact with pedestrians and encourage them to use the tunnel or crosswalks, and to remind pedestrians that they can be fined for interfering with the orderly passage of vehicles (Virginia Code Section 46.2-923). There was discussion that JMU has responded with officers on South Main Street, variable message boards and signage directing pedestrians to cross at the tunnel and crosswalks, there have been email blasts from the University to students, faculty, and staff, and several articles in the Breeze. The result of these activities has been positive with no pedestrians being observed crossing South Main Street midblock. JMU's efforts to use education and enforcement is effective.

4. Update: HRMPO Bicycle & Pedestrian Plan

The HRMPO Bicycle & Pedestrian Steering Committee had its first meeting on January 3. There was a lot of good discussion at this first meeting laying the groundwork for the work to take place over the next 12 months of the plan development. The Steering Committee will be meeting once a month for the next 12 months. The HRMPO Bicycle & Pedestrian Plan website will be published late-February. There will be an online public survey to be released in early-March to solicit input from community members, and later this year there will be a public meeting/ workshop. Kevin McDermott from the Central Shenandoah Planning District Commission is the project manager. He can be contacted at Kevin@cspdc.org.

The Rockingham County Board of Supervisors is considering whether or not to join the HRMPO's study to do a Rockingham County-wide Bicycle & Pedestrian Plan.

5. Update: Safe Routes to School Grant Application for Stone Spring ES Submitted

Ms. Dang shared that the City has submitted a grant application to the Virginia Department of Transportation for infrastructure improvements around Stone Spring Elementary School which includes a proposal for new sidewalks along the east side of Peach Grove Avenue, traffic and pedestrian signals with crosswalks at the school's entrance, and new sidewalk improvements on the school grounds to make it possible and safer from students from the neighborhood across the street from the school to walk to school. The estimated project cost and grant request was for \$333,067. The City does not expect to hear back from VDOT on the grant status until late-Spring.

Ms. Dang thanked the school and parents participating in the development of the School Travel Plan, which was required to be completed and approved by VDOT prior to the submission of the grant application. In addition to describing engineering measures (infrastructure improvements), the School Travel Plan also requires the school and community to address the other 4 of the 5E's; education, encouragement, enforcement, and evaluation. Ms. Johnston has been supporting the school with education and encouragement programs.

6. Update: Downtown Streetscape Plan Public Forum (Date TBD) & Opportunities for Bicycle & Pedestrian Plan

The public forum for the Downtown Streetscape Plan's update is postponed until the City Manager and City Council has had an opportunity to review. More information on the public forum forthcoming. Ultimately, when the plan's development is completed, the Transportation Safety & Advisory Commission and Planning Commission will make their recommendations to City Council and City Council will adopt (or not adopt) the Plan.

Ms. Dang noted that following the update to the Downtown Streetscape Plan, the Bicycle & Pedestrian Plan (as well as the City's Comprehensive Plan and Design & Construction Standards) will need to be amended/updated to be consistent with that is adopted in the Downtown Streetscape Plan.

Ms. Dang stated that the Bicycle & Pedestrian Plan, being last updated in 2010, is due for an update in 2015. This means that city staff, Subcommittee members, and community members should begin working on the Plan update in mid-2014. Ms. Dang recommended that the Subcommittee consider additional amendments to the Bicycle & Pedestrian Plan (outside of the Downtown Streetscape Plan) to be done with the bigger 2015 update so that they can be reviewed as part of a full public input process specifically for the Bicycle & Pedestrian Plan.

7. Mapping information of unused alleys and rights of ways

Ms. Dang reviewed items provided in Attachment B. Mr. Chenault provided an overview of the request, describing city owned alleys and that they were being reviewed for the possibility of closing the alleys (giving/selling ownership of the alley to the adjacent property owners). Public Works, Public Utilities, Fire Department, and other city departments have identified which alleys are not eligible for closure due to needs for utility easements or access ways. City Council asked the Bicycle & Pedestrian Subcommittee

to review the alleys to make sure there was not another need for the alleys, such as usefulness for future trails and pathways.

There was brief discussion regarding the following:

- That some alleys are visible today and that there are some alleys that one would not know it was an alley. City staff has provided maps (Attachment B) for review.
- That there may be safety concerns with encouraging mid-block crossings for a future trail (due to drivers not expecting a crossing mid-block), but that these locations should be evaluated on a case-by-case basis.
- Whether the community would prioritize a trail behind homes or a sidewalk in front of homes first. This may need to be evaluated on a case-by-case basis.
- HPD officers expressed interest in reviewing the alleys for access and they were advised to discuss with the Police Chief and for their department to submit those comments to the City Manager's Office.
- The secondary issue involving the tall grass and weeds ordinance and questions regarding who would maintain the alleys that the city were to keep.

The Subcommittee decided to host a separate meeting so that everyone interested can discuss just the alleys with regard to being possible biking or walking trails. A meeting will be hosted on Tuesday February 19, 2013 at 5:30pm. Comments can also be emailed to Ms. Dang at Thanh.Dang@harrisonburgva.gov or Mr. Jenkins at tj@shenandoahbicycle.com.

8. Update on projects under design/construction (Attachment C)

The projects listed in Attachment C were reviewed.

There was discussion about the overall connectivity in the city, such as how to connect the Northend Greenway to the Bluestone Trail or to Hillandale Park and the High School.

Mr. Eschelman provided an updated to the Newman Lake Dam widening project, which will include widening for a future trail that will connect to the Bluestone Trail into campus. James Madison University established a Bicycle & Pedestrian Advisory Committee (BPAC) that will be working on the development of a Bicycle & Pedestrian Master Plan for the campus. The BPAC is working on the Scope of Work right now.

9. Bike Month Planning is Underway!

Bike Month is in May. Anyone already coordinating a bike event in May, wishing to coordinate a new Bike Month event, or who wants to volunteer to help with an event should contact Suzi Carter, suzi@northendgreenway.org. Ms. Carter said that Bike to Work Day on May 17th will be happening again, and that the planning committee is working on developing more activities for different user groups such as a Mother's Day bike ride or alley cat.

Ms. Johnston added that Bike Rodeos for kids will continue this year also.

ATTACHMENT B: Mapping information on unused alleys and rights of ways

BACKGROUND: City Council was presented with mapping information showing "unused" in the city, and city staff's recommendation for which alleys could be considered for transferring ownership to abutting property owners. (See video of Council meeting here.)

Alleys which city staff believed would be needed for existing or future water and sanitary sewer easements, existing routes for refuse and recycling services, existing or future needs for emergency and fire access, future bicycle and pedestrian facilities, future roadways, etc. are shown on the map as not being eligible for transfer of ownership. City staff has not yet reviewed these maps for potential use for future stormwater management infrastructure, as staff is currently working on a Stormwater Retrofit Study through October 2013.

City Council has requested that the alleys mapping information be given to the Bicycle & Pedestrian Subcommittee to review, and comments from the Subcommittee be reported back to city staff and Council.

In late 2011, Council heard two concerns from the North East Neighborhood Association: (1) there are a number of alleys that have become overgrown and collectors of trash and whose responsibility is it to maintain?; and (2) if the city is not going to maintain, could those alleys be deeded to the adjacent property owner?

Council directed the City Manager to report if there are a lot of "unused" alleys in the city that we do not need to continue to hold onto as rights-of-way and would be better in the hands of abutting property owners. This would give Council useful information on whether or not they should become more active in eliminating unneeded alleys.

A staff team comprised of Police, Fire, Public Works, Parks and Recreation, Public Utilities, and Community Development was formed to conduct the review. Each alley, paper street, etc. was reviewed to determine the current city use including refuse and recycling collection, right of way for utility, etc. and critical access issues for the Fire Department among the most frequently identified.

HISTORY

In 1993, the City adopted a public alley maintenance plan. In summary, the Maintenance Plan says:

- 1. If the alley is used by city refuse collection trucks, the City is responsible for full maintenance of the alley.
- If the alley is not used by city refuse collection trucks, but is used for vehicular traffic, the abutting property owners are responsible for 50% of cost of maintenance and/or improvements.
- 3. If the alley is not open for vehicular traffic, it is to be maintained by the abutting property owners.

RESULTS AND RECOMMENDATION

The staff work group has updated the inventory to make it more "user friendly". The inventory has been developed on GIS and can be easily maintained and viewed by staff. The work group is recommending the following:

- 1. There are alleys that need to be retained by city (Attachment A);
- 2. A preliminary determination has been made of alleys that the city 'does not need' for department specific reasons (Attachment A);
- 3. A proposed list of alleys has been developed for council consideration of "other uses" i.e. networked into proposed trail systems (Attachment A); and
- 4. A recommended revision to Section 16-6-58 of City Code has been suggested to insure that it covers alleys that are not open to vehicular traffic (Attachment B).

ATTACHMENT B

Sec. 16-6-58. - Weeds, etc., on lots.

- (a) Between April first and November first of each year, every owner of real estate situate in the city shall, at his sole expense, cause to be cut therefrom all grass, weeds and foreign growth, with the following exceptions:
 - (1) Farm land on which crops are being grown or land used to pasture livestock.
 - Acreage not farmed or pastured but which is not subdivided and of which no subdivision plat has been recorded. However, on such unused acreage, the owner shall mow a strip twenty-five (25) feet wide adjacent to any street or adjoining property on which a residence is located.
 - (2)(3) Alleys and public streets that are not open to vehicular traffic.
 - (3)(4) Subdivided and recorded residential lots fronting undeveloped public street right-of-ways.
- (b) Upon determination by the city manager, in conjunction with the chief of police, or their agents, that there exists upon any land or premises within the city, including the area in front of such land or premises extending to the curb line, any trash, garbage, refuse, litter and other similar substances which might endanger the health, safety or general welfare of other residents of the city, notice shall be served on the owner or his agent and the occupant of the land or premises to cause such trash, garbage, refuse, litter and other similar substances which might endanger the health, safety or general welfare of other residents to be removed from such land or premises within ten (10) days from the date of such notice.
- Upon determination by the city manager, or his agents, that there exists on any land or (c) premises within the city, including the area in front of such land or premises extending to the curb line, any grass, weeds, brush and other foreign growth not exempt under paragraph (a) above which presents any threat to the health, safety, or general welfare of residents of the city, written notice shall be served on the owner, or his agent, of the land to cause such grass, weeds, brush or other foreign growth to be removed or cut and removed from such land or premises within five (5) days from the date of receipt of, or immediately upon undeliverable return of, such notice. The notice shall state that no further notice shall be given by the city for the remainder of the calendar year. The notice shall further state that the city shall take corrective action as needed, until the end of the enforcement period for the calendar year, and that such costs shall be charged to the property owner as provided in this section. Occurring at the same time as the written notice, notice shall also be posted in a conspicuous place upon the land or premises for a period of at least five (5) days stating the nature of the violation, the action needed to correct the violation and an address and/or telephone number where additional information can be obtained. For purposes of this section, whenever grass, weeds, brush or other foreign growth attains the height of twelve (12) inches or more, it shall be presumed to threaten the health, safety and general welfare of residents of the city.
- (d) The notice provided for in paragraphs (b) and (c) above shall be served in person or be sent by registered or certified mail. One (1) notice per growing season is hereby deemed reasonable notice to owners of property remaining in the same ownership to authorize the city to remove or contract for the removal of any grass, weeds, brush or other foreign growth in violation of this section for the entire remainder of the growing season.

- (s) Upon the failure, neglect or refusal of any owner, agent or occupant of the land or premises upon whom notice has been served as provided in this section to remove or cut and remove such trash, garbage, refuse, litter or other similar substances or grass, weeds or other growth which might endanger the health, safety or general welfare of other residents of the city, within the time indicated in the notice, the city manager or his agent may, without notice, have the requisite work done by city forces or by contract. The actual cost of such work shall be charged to the owner of the land or premises upon whom such notice was served.
- (f) When the city manager has accomplished the removal or cutting and removal of trash, garbage, refuse, litter or other similar substances or grass, weeds or other growth pursuant to this section, he shall bill the owner of the land for the cost of such removal or cutting and removal and the cost of publication, if any. If such bill is not paid within thirty (30) days, the city manager shall transmit such bill to the city treasurer, who shall include such amount in the next regular tax bill of the owner of such property. Every charge authorized herein which remains unpaid shall constitute a lien against such property and may be collected as taxes and levies are collected.
- (g) The failure, neglect or refusal of an owner, agent, occupant or lessee of land or premises, or owner or beneficiary of an easement or other right to use such land or premises, to comply with terms of a notice served pursuant to this section shall constitute a Class 4 misdemeanor. (Code 1972 § 19-55; Ord. of 4-9-85; Ord. of 8-12-86; Ord. of 7-24-12)







PROJECTS UNDER CONSTRUCTION, OR SOON TO START CONSTRUCTION

- University Boulevard Sidewalk Phase I Construct sidewalks along the north side of University Boulevard between East Market Street to Evelyn Byrd Avenue, and a portion of Evelyn Byrd Avenue on the west side between University Boulevard and the existing sidewalk. Pedestrian signals to also be installed at the intersections of University Boulevard & Evelyn Byrd Ave, and University & Valley Mall entrance (at existing traffic signal). Funded by City.
 - UPDATE: This project is currently under construction.
- Safe Routes to School: Waterman Elementary School Sidewalks on west side of Chicago Avenue between 2nd Street and Rockingham Drive, bike lanes on Chicago Avenue between Gay Street and Rockingham Drive, sidewalk on south side of 3rd Street between Collicello Street to Stuart Street, sidewalk on east side of Stuart Street, sidewalks on both sides of Virginia Avenue from about 2nd Street o 5th Street. Estimate cost: ~\$610,000. Funded by VDOT SRTS Program and anticipated Community Development Block Grant Funds. http://www.harrisonburgva.gov/waterman-safe-routes
 - UPDATE: Invitation to bid currently out and bids are due January 31. Construction is scheduled to start on/around March 1.
- **Erickson Avenue-Stone Spring Road Phase III** Road improvement project includes new sidewalks and bike lanes. www.ericksonstonespring.org.
 - UPDATE: Project under construction.

PROJECTS UNDER DESIGN/ PLANNING

- Bluestone Trail Phase I Construct a 10-ft wide shared use path between Port Republic Road at
 Bluestone Drive to Wellness Drive off Berry Road. Estimated cost: Being developed. Anticipated
 construction advertisement May 2014. Partially funded by: DCR Land & Water Conservation
 Fund Grant. More information available at: http://www.harrisonburgva.gov/Bluestone-Trail
 - UPDATE: Waiting for notification of award from VDOT for Revenue Sharing Funds. In the meantime, public works staff and McCormick Taylor are meeting with property owners to review preliminary alignments, and are working on additional surveys of properties. Environmental surveys also underway.
- Cale Trail Shared use path to connect Thomas Harrison Middle School and Westover Park
 through the former Cale property that was donated to the City by Dr. William Cale and Mrs.
 Susan Cale.
 - UPDATE: Parks & Recreation has begun clearing the corridor. Once completed, city staff and Shenandoah Valley Bicycle Coalition volunteers will go back out to evaluate the terrain and develop next steps and costs estimates to complete the project (to make it ADA accessible and pave it). We are not ready to promote the trail for public use. City staff and volunteers are meeting with Thomas Harrison Middle School staff and parents

in February to determine alignment between former Cale property to the school entrance.

- Downtown Streetscape Plan Update Update of previous Downtown Streetscape Plan (2004) to provide a comprehensive downtown streetscape plan that will develop a vision for all streets in the study area to develop public and private expectation for project elements. Study areas include the Downtown Core, Downtown Transition Area, and Downtown Gateways. More information available at: http://www.harrisonburgva.gov/downtown-streetscape-plan
 - Staff will present draft plan to Council in February and go to public input meeting in Spring 2013.
- East Market Street Sidewalk Phase IV Construct a 5-ft wide sidewalk with 2-ft grass strip on south side of East Market Street between Carlton Street and 400' north of Hawkins Street. This project will also include pedestrian signals at the intersections of East Market Street with Carlton Street and Hawkins Street/Vine Street. Estimated cost: greater than \$ 400,000. Funded by VDOT Highway Safety Improvement Program.
 - UPDATE: Engineering design underway by city staff. Staff anticipates starting the rightof-way phase in late-winter/early-spring 2013.
- Northend Greenway 2.5-mile Shared use path that will run between Park View area (near EMU/EMHS) that will mostly follow Blacks Run into downtown (near Washington St & N Main St), then travel via Federal Street alley to the Farmers Market. This project will be completed in multiple phases which have not been finalized yet. This is a public-private partnership between the City, and New Community Project and Northend Greenway volunteers. Estimated cost: Being developed.
 - O UPDATE: The City has contracted with McCormick Taylor to continue this project. McCormick Taylor, and subconsultants Coleman Engineering and Johann Zimmerman, will be working on the "Northend Greenway Concept Development Phase" through April 2013 which includes base mapping, environmental overviews, and work which will result in a document called "Northend Greenway Design Principles". A public meeting workshop is anticipated around March/April 2013. Also awaiting for notification of award from VDOT for Revenue Sharing Funds.
- Reservoir Street Project Widen Reservoir Street to sections of 5-lane facility and 4-lane facility with median. Project will include sidewalks on both sides and bike lanes.

 - UPDATE: Engineering design and right-of-way negotiations with property owners is currently underway. Project anticipated to go to construction in 2014.
- Thomas Harrison Middle School to Hillandale Park connectors Construct a path from Wyndham Wood Drive to Thomas Harrison Middle School and West Market Street, and a path between Circle Drive to Hillandale Park. This project is in the planning phase and is not yet funded.
 - UPDATE: Bike-Ped Subcommittee members discussing with property owners.
