- 1. <u>Election Day Holiday</u>: The Harrisonburg City Council voted on September 26<sup>th</sup> to make November Election Day a city holiday going forward. We will be the only department in the building working that day. I will need to coordinate with other Department Directors to make sure we have people on call for the services we may need.
- 2. <u>Fire door for Atrium</u>: The Harrisonburg Fire Chief did an inspection of City Hall on Friday September 29<sup>th</sup>. He informed us that we can't prop the door to the Atrium open any longer. Based on a recommendation from Ms. Gerald we requested that the City Hall building manager get a fire door magnet system installed so that we can have these doors open. I will update you when we have more info.
- 3. <u>Early Voting:</u> Early voting has begun; turnout has been slow but steady.
- 4. <u>Events:</u> I went to HHS during lunch periods on September 18<sup>th</sup> to register students to vote. I was able to answer questions for students and faculty, and the QR for the website was utilized multiple times. I collected only two applications.
- 5. <u>Numbers:</u> As of Friday September 29<sup>th,</sup> we have mailed 612, and emailed 14 ballots. So far 148 have been returned. We currently have 6 in the cure process and 6 came back undeliverable. And 198 people have voted in person during Early Voting.
- 6. <u>Staffing</u>: The new Chief Deputy Registrar Lisa McDonald will start on October 4<sup>th</sup>.
- 7. <u>OOE:</u> Ms. Gerald has completed a tentative schedule for election day for your review.
