DEPOSITS

For NEW accounts, a deposit is required before service is furnished. The deposit shall be in the following amounts:

Residential (Single Family & Duplex) 5/8" – 1 1/2" meters	\$ 150.00
Large Consumers – 2" or Larger Size Meter	\$ 300.00
Refuse Accounts Only	\$ 50.00

CURRENT LETTER OF CREDIT FROM WATER, ELECTRIC AND GAS COMPANIES ARE ACCEPTED
- pending no late fees in the prior 12 months and prior service end date is within most recent 30 day period.

SEASONAL RATE

In addition to the city and rural water rates as set forth above, there shall be added to all water bills generated in the months of July, August, September, October, and November of each year a seasonal water rate charge per one thousand (1,000) gallons.

UTILITY TAX

A twenty percent (20%) utility tax is added to the total water bills of all City and Rural users, a maximum two dollars (\$2.00) for residential; a maximum of twenty dollars (\$20.00) for commercial;

REGULATIONS

All unpaid accounts are subject to discontinuance of service one (1) month and five (5) days after past due. (Refers to the initial due date). Written notice will be given in the monthly statement.

RE-CONNECTION CHARGES

Any person, firm, or corporation whose utility service has been discontinued for non-payment of account shall, before the service is re-established, in cash or certified funds pay all delinquent and current bills in addition to the following charge:

Thirty-five dollars (\$35.00)

After hours re-connections are one hundred seventy five dollars (\$175.00)

UTILITY SERVICE FIELD CALL CHARGE

Next day service twenty-five dollars (\$25.00) – Same day service seventy-five dollars (\$75.00) for turning on the water service or transferring account ownership, which charges shall be included on the first monthly statement submitted after the service is cut on. There is no charge for turning service off. **AFTER HOURS FIELD CALLS ARE \$175.00.**
